GUIDE TO THE SAN BERNARDINO SUPERIOR COURT REORGANIZATION

The San Bernardino County Superior Court has announced that the new courthouse (San Bernardino Justice Center) will open for business in May of 2014. As a result, the court has announced the following changes:

1. Effective May 12, 2014 Civil Limited and Unlimited cases from the **Rancho Cucamonga District will be filed and heard in the new San Bernardino Justice Center.**
2. Effective May 12, 2014 Civil Limited and Unlimited cases from the **San Bernardino District's Historic Courthouse will be filed and heard in the new San Bernardino Justice Center.**
3. Effective May 19, 2014 Criminal Felony and Misdemeanor cases from the **San Bernardino District's Historic Courthouse will be filed and heard in the new San Bernardino Justice Center.**
4. Effective May 19, 2014 all Capital/Death Penalty cases **will be filed and heard in the new San Bernardino Justice Center.**
5. Effective May 27, 2014 Family Law cases from the **Rancho Cucamonga District will be filed and heard in the San Bernardino District's Historic Courthouse.**
6. Effective May 27, 2014 Family Court Mediation matters from the **Rancho Cucamonga District will be scheduled and held in the San Bernardino District's Historic Courthouse.**
7. Effective May 27, 2014 Criminal Felony and Misdemeanor cases from the **Fontana District will be filed and heard in the Rancho Cucamonga District.**
8. Effective May 27, 2014 Traffic and Non-Traffic Infractions from the **Rancho Cucamonga District will be filed and heard in the Fontana District.**
9. Effective May 27, 2014 Traffic and Non-Traffic Infractions from the **San Bernardino District's Historic Courthouse will be filed and heard in the Fontana District.**
10. Effective May 27, 2014 the **Self-Help Resource Center in the Rancho Cucamonga District will be closed.** Self-Help Services will be available in the San Bernardino District's Historic Courthouse.
11. Effective May 27, 2014 the Court Investigators Unit will be **relocated to the new San Bernardino Justice Center.**
12. Effective June 2, 2014 the Appeals and Appellate Division will be **relocated to the new San Bernardino Justice Center.**
13. Effective June 2, 2014 Small Claims and Landlord Tenant cases from the **Rancho Cucamonga District will be filed and heard in the Fontana District.** Small Claims and Landlord Tenant cases will no longer be filed or heard in the Rancho Cucamonga District.
14. Effective June 2, 2014 Civil Harassment Restraining Orders, Elder Abuse, Name Change or Firearm Petitions for the **Rancho Cucamonga District will continue to be filed and heard at the Rancho Cucamonga District.**
